Software requirements for hosting

- PHP 5.6, 7.0, 7.1, 7.2, 7.3, 7.4 (for 5.3, 5.4, 5.5 send request by email)
- ionCube PHP Loader latest version (ask your hosting provider)
- PHP OpenSSL support
- PHP mbstring support

Compatible versions of OpenCart

- OpenCart 3.0.x.x, 2.0.x.x, 2.1.x.x, 2.2.x.x, 2.3.x.x, 1.5.5.x, 1.5.1.x
- ocStore 3.0.x.x, 2.0.x.x, 2.1.x.x, 2.2.x.x, 2.3.x.x, 1.5.5.x, 1.5.1.x

To work with the .csv files require an Apache OpenOffice Calc office package, this is an application for spreadsheet that allows you to work with files in the .csv format.

How to force Microsoft Office Excel to open and save CSV files in the UTF-8 encoding - ask Google or refer to the official product documentation for Microsoft Office.

Check the system settings with system_test.php

To check the settings of your server, download archive file system_test.zip. Use an FTP client to upload file "system_test.php" to root directory of your website. Depending on your hosting, it may be named "public_html", "www", "mainwebsite_html", "htdocs" or something like that.

When file is uploaded, open your browser and enter the following URL into location bar:

```
http://www.yoursite.com/admin/system_test.php
```

Replace "www.yoursite.com" with your own domain name.

The file will output the diagnostic results and give you further instructions.

After checking, please remove the file system_test.php.

Before installation

If you have an old extension version

- 4.3.3.21 (and older) for OpenCart 2.x.x.x
- 5.0.12.21 (and older) for OpenCart 3.x.x.x

It is necessary to uninstall extension in the list of modules and delete old directories and files:

```
admin/model/csvprice_pro/*
admin/language/ru-ru/csvprice_pro/*
admin/language/en-gb/csvprice_pro/*
admin/language/ua-uk/csvprice_pro/*
admin/controller/csvprice_pro/*
admin/view/template/csvprice_pro/*
cli/csvprice_pro_cron.php
cli/csvprice_pro_cron_config.php
```

Installation

Before installation on OpenCart 2.x

Install iSenseLabs' extension, this is a mod for the new OCMOD modification system in OpenCart 2.x. It allows you to install zipped extensions without the need for FTP support on your server.

```
opencart-2.x/OpenCart2_fix_installer.ocmod.xml
```

to install this mod go to your OpenCart admin panel **Extensions > Extension Installer**. Click the Upload button and select the .xml file that you previously unzipped. You should get a green message saying: "Success: You have installed your extension!". Now navigate to **Extensions > Modifications** and click on the Refresh button at the top right corner of the screen.

After checking system requirements with ***system_test.php***, select the correct archive of your version PHP, for the installation:



Installation Step One

Example OpenCart 3.0.3.7 and PHP 7.3

In Admin go to **Extensions > Extension installer** (in latest versions just Installer). Hit Upload button and upload the correct OCMOD file.



To make the OCMOD extension's changes visible you need to go to **Extensions > Modifications** and hit Refresh button (top right).

After hit Edit button and enter the license key in the "About" (About and Support) tab.
